EDUCATIONAL NOTIFICATION

Online Registration from the NEET-UG-2020 successful eligible aspirant candidates will be invited shortly for the 1st Round of Counselling for admission to MBBS/ BDS/BHMS/BAMS & BASLP Courses in Regional Institute of Medical Science, Imphal, Agartala Government Medical College, Agartala, Tripura Medical College, Hapania, Tripura, National Institute of Homoeopathy, Kolkata, Midnapore Homoeopathic College, West Bengal, MMM Govt. Ayurvedic College, Udaipur, Rajasthan, Gour Brahmin Ayurvedic College, Haryana against the Tripura State Quota seats.

AND

All India other than Tripura Domicile MBBS seats at Tripura Medical College, Hapania, Agartala are invited with requisite registration fees for the academic session 2020.

Only registered candidates will be eligible for appearing in the Counselling. All admission of the selected /allotted candidates are subject to satisfying the verification process of original documents of a candidate in the allotted Institutions before admission.

All original documents of a candidate shall have to comply with the data particulars inserted/uploaded by a candidate during filling NEET UG 2020 Application Format to the **website ntaneet.nic.in** as well as on the Registration Format of this Tripura State NEET-UG-2020 Counselling to the **website dme.tripura.gov.in**

The category inserted in the NEET UG 2020 examination Application Format in the National Testing Agency (N.T.A) **website ntaneet.nic. in** by a candidate will be taken as final and a candidate is liable to prove all the particulars such inserted by his/her original documents in support, in the physical verification process before admission. No change of category will be accepted for a candidate after having already registered in N.T.A website in a particular category by that candidate.

Allotment and Nomination of a selected candidate in the Counselling will automatically stand cancelled if a candidate fails to produce any of the original document in favour of his/her inserted particulars in the NEET UG 2020 examination Format as well as in Registration Format of the Counselling.

The reservation for PwD candidates will apply in the Seat Matrix as per Rules. Candidates belonging to PwD category shall have to produce their respective original Authentic valid Certificate from the Disability Board of Agartala Government Medical College & GBP Hospital, Agartala or any other Disability Board recognized by Medical Council of India(MCI) for verification.

Candidates belonging to ST/SC/ or OBC/EWS/WESM also shall have to produce their original authentic valid certificates for verification at the time of Physical Verification process which will be held in the Institutions accordingly. Failure to produce appropriate original authentic certificates will lead to cancellation of a Selection/Allotment/Admission of a candidate.(for All India other than Tripura Domicile) and candidates participating for State Quota Seats, belonging to Eligibility Criteria from 1 to 5 who also shall have to produce their original Authentic Certificate of all Eligibility Criteria for Physical Verification in the allotted Institutions accordingly.

Candidate must obtain the Qualifying marks as per category as published by N.T.A to be eligible to participate in the Counselling and to be allotted a seat accordingly.

- 1) Candidates can apply for registration for participation in the Round-1 and Round-2 Counselling of Tripura State NEET UG 2020 through “**Online**” Mode only.
- 2) Submission of Online Application Form may be done by accessing the portal w.w.w. www.mcc.tripura.gov.in
The Application Form in any other Mode will not be accepted for Round 1 and Round 2.
- 3) Candidates must follow the instructions etc. given in our earlier Educational Notification of even number dated 19th October, 2020
- 4) Candidates must ensure that e-mail address and Mobile Number provided during the Registration of the Counselling are their own or their parents only as information/communication whenever in need will be sent from Director of Medical Education, Govt. of Tripura/NIC through e-mail on the registered e-mail address or SMS on registered Mobile number only for all future communications.
- 5) Instructions for filling Online Application Form/Registration for Counselling –
 - i) Download All Education Notification and Replica of Application Format. Read these carefully to ensure your eligibility for participation in the Counselling.
 - ii) Down Load Information Bulletin of National Eligibility Cum Entrance Test (UG) 2020.
Read these carefully including Chapter 4 Eligibility & Qualification at Page No.15 to 19 to ensure your eligibility for Participation in the Counselling which will be binding to the Eligibility and Qualification (including Age and obtained marks of Qualifying exams) with which one eligibility to appear in NEET UG 2020.
 - iii) Admission and Reservation will be as per Reservation Policy and Eligibility Criteria as per “Admission and Reservation” described in Chapter 5 Page No.20 to Page No.23 of Information Bulletin of national Eligibility Cum Entrance Test(UG) 2020.
 - iv) Counselling and Admission for seats other than 15% All India seats will be as per “**Instructions for Counselling**” stated in Chapter 14 Page No.38 of Information Bulletin of National Eligibility Cum Entrance Test(UG) 2020.
 - v) Before choice filling a candidate is instructed to see the seat Matrix of each courses including related Institutions very carefully and then insert their choices as per preference.
 - vi) First Round of Counselling is a **FREE EXIT ROUND**. A candidate allotted a seat in the 1st Round may not take admission in the allotted seat in the due time of admission will be automatically eligible for Second Round participation. After taking admission in the allotted seat of Round 1, a candidate may opt for up gradation in the Round 2 and then he/she can participate in Round 2 seat allotted in Round 2 will automatically nullify/voied any allotted/Admitted seat in Round 1.
 - vii) The allotment/selection of candidates in Round 1 Counselling will be published in the DME website and after that a candidate may download his/her allotment from the Counselling link which have to be submitted by the candidate in the office of Director of Medical Education to collect Nomination for the allotted seat. A candidate with the Nomination letter will have to attend the allotted Institution for necessary physical verification of his/her documents, submission of requisite fees and admission accordingly.
 - viii) Candidates are instructed to visit the website of Sponsoring Colleges for all information regarding the course fees, other pre-requisite for admission, admission procedure etc.

Before filling the information to be filled in the **“Online Application Form”** following preparations are to be made by a candidate :

Names of Candidate, Father/Mother with correct spelling, Adhaar Number (last 4 digits)/ Class-XII standard or equivalent qualifying exam as published by NTA in the Information Bulletin for NEET-UG-2020 along with Roll Number of that qualifying exam issued by approved Board/University. Election Card(EPIC NO)/ Passport Number/ Other valid Govt. Identity Card Number. Date of Birth, Address of the applicant with Mobile Number/E-mail ID etc. may be kept ready as any one of the above may be needed to be provided for Identity .

Candidates should have scanned Images in JPG/JPEG Format only for Uploading the following documents and for filling the said Application Form in Online Mode.

1. Madhyamik /Class-X Admit Card/ H.S.(+2 Stage) Admit showing Date of Birth.
2. Mark sheet of 12th Standard Qualifying NEET-UG-2020 Examination or Qualifying Examination Criteria.
3. Permanent Resident Certificate of Tripura(For State Domicile/Quota seats).
4. Certificate of Reservation Category(as and wherever applicable) ST, SC & OBC
5. Prescribed Disability Certificate (as and wherever applicable).
6. Prescribed Income and Assets Certificate to be produced by EWS Section(as and wherever applicable)
7. Authentic valid certificate for WeSM(as and wherever applicable)
8. NEET-UG-2020 Score and Rank Card.

- Merely appearing/participating in the Tripura State NEET UG 2020 Counseling does not confer any right to the Candidate for Selection/ Allotment/Admission to Undergraduate Medical Courses. The Selection and admission to Undergraduate Medical Courses seats in any Medical Education Courses is subject to fulfilling the admission Criteria, Eligibility, Rank in merit list, medical fitness and such other criteria's as may be prescribed by the Government of India, State Government, Universities, Institutions and Medical/Dental/Ayurveda /Homeopathy Colleges.
- Applications of Candidates submitting false and fabricated information will be rejected and such candidates will be further debarred from appearing in examinations conducted by NTA or Tripura State NEET UG Counseling. Such Candidates may also be prosecuted under applicable laws for Criminal offense and suitably punished.
- Incomplete Application and applications not in accordance with instructions are liable to be rejected without any further intimation.
- The Registration fee once deposited will not be refunded Such fee will neither be carried/forward to a future counseling or refunded.
- Applications once submitted cannot be withdrawn. Candidates must note that mere deduction of fee from the Bank Account is not a proof of fee payment. The payment should be supported by fee payment and "Generation of Confirmation Page".
